

PUBLIC HEARING – ROAD DISTRICT BUDGET

APRIL 23, 2024

MINUTES

The Public Hearing was called to order at 5:00 p.m. by the Chairman who stated that in Accordance with the law, the meeting was open for the purpose of conducting a public Hearing in accordance with the published (posted) notice that such hearing on the Tentative Budget and Appropriation Ordinance for the Road District, as proposed by the Highway Commissioner. A public hearing and general discussion then took place as to such ordinance.

The Chairman stated that the public hearing was concluded.

Thereupon the Town Clerk stated that the Tentative Annual Budget and Appropriation Ordinance heretofore filed in the office of the Town Clerk by the Highway Commissioner Had been made conveniently available for public inspection for more than thirty (30) days prior to April 23, 2024, that he gave public notice that such Tentative Annual Budget and Appropriation Ordinance had been filed in his office and was conveniently available for public Inspection at his office; and that a public hearing was held before the Town Board of Trustees on April 23, 2024 and that notice of such public hearing was given at least 30 days in advance by publication in The Decatur Tribune newspaper.

The Chairman announced that it was now in order for the Board to consider and take final action on said Ordinance. Thereupon, the Clerk presented the Annual Budget and Appropriation Ordinance in words and figures as prepared by the Highway Commissioner.

A general discussion followed.

Thereupon on a motion by Mike Reynolds, seconded by Karen Kelly, the following Resolution was adopted:

BE IT RESOLVED, that the Tentative Annual Budget and Appropriation Ordinance for the Highway Commissioner of this Town, for the ensuing fiscal year, heretofore filed in the office of the Town Clerk be and the same is hereby adopted as and for the final Annual Budget and Appropriation Ordinance of the Highway Commissioner of this Town for the ensuing fiscal year.
